Ozurtextxa® is a centrally acting alpha2-adrenergic agonist indicated for the treatment of attention deficit hyperactivity disorder (ADHD) as monotherapy or as adjunctive therapy to stimulant medications. The efficacy of Ozurtextxa is based on the results of two clinical trials in children and adolescents. Maintenance efficacy has not been systematically evaluated, and patients who are continued on longer-term treatment require periodic reassessment.

Indication

Ozurtextxa® is a prescription medicine used for the treatment of Attention-Deficit Hyperactivity Disorder (ADHD). Your doctor may prescribe Ozurtextxa® alone or together with certain other ADHD medicines.

Ozurtextxa® is not a central nervous system (CNS) stimulant

Ozurtextxa® should be used as part of a total treatment program for ADHD that may include counseling or other therapies

Important Safety Information for Patients

Do not take Ozurtextxa® if you are allergic to clonidine.

Ozurtextxa® may be used alone or with a stimulant

Ozurtextxa® may have been prescribed as a single medication to treat your child's ADHD

Ozurtextxa® alone has been proven to improve ADHD symptoms

Ozurtextxa® may have been added to your child's current stimulant medication

Ozurtextxa® is proven to help improve ADHD symptoms better than a stimulant alone

What's more, when Ozurtextxa® is added to a stimulant, the stimulant dose can be adjusted/lowered based on patient response

Ozurtextxa® has been proven to improve symptoms of inattentiveness and hyperactivity/impulsivity

Ozurtextxa® is a non-stimulant medication for treating your child's ADHD.

Be confident in Ozurtextxa® because:

It is not a controlled substance

It has no known potential for abuse or dependence

It is easily refilled—over the phone, at the pharmacy, or through mail order.

Dosing should be initiated with one 0.1 mg tablet at bedtime, and the daily dosage should be adjusted in increments of 0.1 mg/day at weekly intervals until the desired response is achieved.

Available in two strengths: 0.1 mg / 0.2 mg extended-release tablets.
