Stillivant® XR (methylphenidate HCl) is a liquid medicine that is taken by mouth, once in the morning. The recommended starting dose is 20 mg. However, your child's doctor may adjust the dose. The dose may be titrated weekly in increments of 10 mg to 20 mg. Daily doses above 60 mg have not been studied and are not recommended.

Stillivant® XR (methylphenidate) is a central nervous system (CNS) stimulant indicated for the treatment of Attention Deficit Hyperactivity Disorder (ADHD).
Before administering the dose, vigorously shake bottle for at least 10 seconds.
May be taken with or without food.
For patients 6 years and above, recommended starting dose is 20 mg given orally once daily in the morning.

INDICATION

Stillivant® XR is a **central nervous system (CNS) stimulant prescription medicine. Stillivant® XR is used for the treatment of Attention Deficit Hyperactivity Disorder (ADHD).** Stillivant® XR may help increase attention and decrease impulsiveness and hyperactivity in patients with ADHD.

Stillivant® XR is a federally controlled substance (CII) because it can be abused or lead to dependence. Keep Stillivant® XR in a safe place to prevent misuse and abuse. Selling or giving away Stillivant® XR may harm others and is against the law. Tell your doctor if you or your child have (or have a family history of) ever abused or been dependent on alcohol, prescription medicines, or street drugs.

Stillivant® XR should not be taken if you or your child are allergic to methylphenidate hydrochloride, or any of the ingredients in Stillivant® XR, or are taking or have taken within the past 14 days an antidepressant medicine called a monoamine oxidase inhibitor or MAOI.

Stillivant® XR (methylphenidate HCl) is the first and only once-daily extended-release liquid medicine for Attention Deficit Hyperactivity Disorder (ADHD).

- May help improve attention and behavior—in children with ADHD. Stillivant® XR can also be prescribed for adolescents and adults.
- Long-acting medicine—works in 45 minutes and keeps working 12 hours after taking.
- Fruit-flavored liquid medicine—taken once in the morning, with or without food.

Stillivant® XR comes with an oral dosing dispenser. This will help you measure the amount of medication needed for the day.

The efficacy of Stillivant® XR was established in a 2-week, placebo-controlled trial in children aged 6–12 years with a diagnosis of ADHD. Accumulated efficacy data from other methylphenidate products were also considered.

Dosage : Extended-release oral suspension (after reconstitution with water): 25 mg per 5 mL (5 mg per mL).
